- that this photo will be processed in accordance with the Regulation (EU) 2016/679 of the European Parliament and the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), by Port of Antwerp-Bruges, with its registered offices at Zaha Hadidplein 1, 2030 Antwerp, BE 0248.399.380, party responsible for processing;
- that the person who submitted the photo (participant in the campaign) has declared and guaranteed that he/she has the right to reproduce the photo of support, to share it with the public and use it; and any persons involved (authors, pictured persons, etc.) have given their explicit and prior permission (and if the pictured person is younger than 16, that of the parents) concerning the above;
- that the photo is only processed for the purposes of:

The abovementioned personal data will not be transferred to third parties (with the exception of processors, see above under 3.) and are saved for as long as required in the light of the purposes as specified above, i.e. for the publication of the photos mentioned under 3., for two years starting from the time of your photo being submitted through the campaign page on www.antwerpmarathon.com.

The individual provision of the abovementioned information to you beforehand would be impossible.
